 - **4.1.1 ICD:** An ICD is the starting point for new capability requirements to provide the desired war fighting material solution.  - **4.5.1 ACAT 1D**: This program is a Major Defense Acquisition Program (MDAP) whose milestone decision authority is the Defense Acquisition Executive.
 - **4.5.2 ACAT 1C:** This program is a MDAP whose milestone decision authority is the Army Acquisition Executive.
 - **4.5.3 ACAT 1AM:** This is a major automated information system, or a program that has been designated ACAT 1A by the Defense Acquisition Executive due to special interest. The milestone decision authority is the Defense Acquisition Executive.
 - **4.5.4 ACAT 1AC:** This is a major automated information system, or a program that has been designated ACAT 1A by the Defense Acquisition Executive due to special interest. The milestone decision authority is the Army Acquisition Executive.

- **4.5.5 ACAT II:** The ACAT II programs do not meet the criteria for ACAT I programs, but are major acquisition systems or are designated as ACAT II systems by the Army Acquisition Executive.
- **4.5.6 ACAT III:** These programs are non-major acquisition programs.
- 4.6 **DoD Oversight:** The Office of the Secretary of Defense publishes an Oversight list for Major Defense Acquisition Programs and other programs.
